## SAMA AND THE 2025 REVALUATION

The Saskatchewan Assessment Management Agency (SAMA) is the leader and authority on property assessment, and Saskatchewan's service provider of choice. The Agency is responsible for assessment governance of the \$271 Billion property assessment base, and a \$2.33 Billion property tax base. The Agency provides assessment valuation services to 762 urban, northern and rural municipalities. It is directly responsible for the assessed values of approximately 876,000 properties in the province.

SAMA conducts revaluations based on a four-year cycle. 2021 was the year of the last revaluation, and the 2025 Revaluation will see assessed values updated to reflect a new valuation base date of January 1, 2023. The legislated base date means that 2025 values reflect a property's value as of January 1, 2023.

Assessments in Saskatchewan are historical. In other words, the date of valuation for a property is in the past. For 2025 to 2028, property values will reflect the market conditions as of a valuation date of January 1, 2023.

SAMA cannot consider sales from after January 1, 2023, when implementing new values with the 2025 Revaluation. SAMA will consider any sales from after the valuation date for the next revaluation.

The 2025 Revaluation will continue to use the market valuation standard for the assessment of residential and commercial properties. The regulated property assessment valuation standard will continue to be used for the assessment of agricultural land, heavy industrial property, railway roadway, pipelines and resource production equipment (mines and oil and gas wells).

For the 2025 Revaluation, all property types will have their values updated in relation to the **January 1, 2023**, valuation base date, regardless of being subject to a market valuation standard or a regulated property valuation standard.

The 2025 Revaluation continues SAMA's goal of stabilizing the assessment system from a governance perspective by not introducing any major changes to assessment policy.



### THREE PROPERTY VALUATION APPROACHES

There are three generally accepted appraisal techniques used to value property under the market valuation standard: the cost approach, the sales comparison approach and the property income (rental) approach.

The **cost approach** estimates the replacement cost of a building, less depreciation, adding land value primarily based on sales. This approach is most useful when there are few comparable sales. The cost approach will continue to be used in smaller municipalities and for specific property types across Saskatchewan.

The **sales comparison approach** is based on the concept of valuing property based on what similar property in the same market area is selling for. This approach is appropriate for determining property assessments for areas and property types with active sales markets such as residential property in medium to large cities.

The **property income (rental) approach** to value is based on the premise that the value of a property is directly related to the rental income it will generate. The assessment appraiser analyzes the property's ability to produce a future income stream, and then estimates the property's value. The property income (rental) approach provides the most fair, reliable and accurate assessed values for commercial property and rental apartments in areas where there are active lease and rental markets.

To ensure assessed values are as accurate as possible, SAMA's professional assessment appraisers collect and analyze available cost, market and property rental income information and use the valuation approach that provides the best estimates of value for each property type, based on available information.

### PRELIMINARY ASSESSED VALUES FOR 2025

The following chart uses provincial averages in SAMA jurisdictions to show preliminary provincial assessment trends for various property types. These are preliminary trends for the entire province. Local property specific taxable assessment trends may vary from the indicated provincial trend depending on how local market conditions compare with the provincial averages used to establish the assessment trends noted below.





## REVENUE NEUTRALITY

While a revaluation updates property assessments, the overall impact on property tax is designed to be revenue neutral on a municipal basis.

Provided that a municipality's budget requirements remain the same in a revaluation year as in the previous year, changes in taxable assessments will only result in changes to tax levels if a property's assessment increases or decreases, relative to the average for that jurisdiction.

Based on the current provincial government practice of establishing common provincial education mill rates, education revenue neutrality and potential education tax shifts will be based on how a specific assessment change relates to the overall provincial average increase in assessments for that same category of properties.

## NEW PUBLICATIONS

The SAMA Board of Directors has approved two new publications for use in preparing 2025 Revaluation assessments:

1. *Saskatchewan Assessment Manual (2023 Base Year)*
2. *SAMA's 2023 Cost Guide*

SAMA also uses the *Market Value Assessment in Saskatchewan Handbook* for valuing properties to meet the market valuation standard.

SAMA's stakeholders, through the Agency's advisory committees, reviewed and contributed to these publications. The *Saskatchewan Assessment Manual* has the force of regulation and must be complied with, while the *Cost Guide* and *Market Value Handbook* do not – they are documents within the market valuation standard.

The **Saskatchewan Assessment Manual** is used to value agricultural land, heavy industrial property, railway roadway, pipelines and resource production equipment (mines and oil and gas wells).

**SAMA's 2023 Cost Guide** is a non-regulated document to be used as a reference for SAMA assessment appraisers and the public regarding the application of the cost approach for the valuation of vacant urban land, residential property and selected commercial property for the 2025 Revaluation.

The **Market Value Assessment in Saskatchewan Handbook** provides guidance for the assessment of market valuation standard properties with a focus to commercial property and the property income (rental) approach.

Like *SAMA's 2023 Cost Guide*, the handbook is a non-regulated document. It is intended as a reference tool for assessment appraisers and the public in determining assessments for the 2025 Revaluation.

Hard copies of these publications will be provided for a fee that covers the cost to print the documents and any applicable licence fees and will include an update service.

The *Market Value Assessment in Saskatchewan Handbook*, portions of the *Saskatchewan Assessment Manual (2023 Base Year)* and *SAMA's 2023 Cost Guide* for which a licence fee is not payable, are available free of charge on SAMA's website ([www.sama.sk.ca](http://www.sama.sk.ca)).

## OTHER COST GUIDES

When applying the cost approach, assessment service providers may refer to publications from Marshall & Swift (Core Logic Inc.), a recognized industry leader in costing of commercial and residential property. SAMA uses the Marshall Valuation Service for the majority of commercial properties valued using the cost approach. *The Residential Cost Handbook* can be used for estimating replacement costs for both single and multi-family residences. SAMA's Cost Guide, the Handbook and Marshall and Swift's Marshall Valuation Service complement each other with the application of the cost approach.

## LOOKING FORWARD TO 2025 – WHAT'S NEXT?

Detailed property specific values were provided to the Saskatchewan Ministry of Government Relations by April 1, 2024. Government Relations then uses this information to determine percentages of value and other relevant information. Preliminary 2025 property values were also distributed to municipalities starting in June 2024.

Although local governments already have the authority to mitigate overall/average assessment changes through their annual budget and mill rate processes, all parties will benefit from time to examine the assessment shifts and make tax policy decisions prior to 2025.

SAMA expects government to announce the 2025 percentages of value for each property tax class in fall 2024, communicating them with SAMA and other independent assessment service providers so that we can prepare final assessed values for 2025.

SAMA is targeting to start delivery of final assessed values to municipalities in January 2025. We will work closely with our client municipalities to meet their needs regarding these new values.

SAMA will have 2025 Revaluation information on our website ([www.sama.sk.ca](http://www.sama.sk.ca)) and updated individual property values will be available on our SAMAView service in early 2025.

The Agency will be making use of SAMAView, our tool that allows the general public access to individual property assessments for all SAMA client jurisdictions, to communicate assessed values for the 2025 Revaluation. However, SAMA will not post any final 2025 Revaluation property assessments before they have been seen by municipalities.

### Weeds to Watch For: Common Burdock

Common Burdock is a biennial that grows into large, stout flowering bolts with many branches up to 3 meters tall. Distinct features include the large alternate wavy or toothed-shaped leaves that are woolly on the undersides, purple flowers, and clinging burrs. The weed reproduces by seed, producing up to 16,000 seeds per plant. Its prickly seed heads, often called burrs, are designed for seed dispersal by attaching to animals that brush by the plant. These thick-stemmed plants may still be observed in winter standing above the snow allowing for identification year-round.

Common Burdock is designated as a noxious invasive weed under *The Weed Control Act* in Saskatchewan. It can be a serious issue in areas where the soil has been disturbed – but not cultivated, and in riparian areas. These weeds outcompete other plants by blocking light with their large leaves, leading to dense patches of common burdock.

Burdock can be controlled through cultivation, grazing of sheep/goats, and chemical control. This weed is one of the designated noxious weeds covered under the **Invasive Plant Control Program**.

#### Did You Know Your PHTA Can Help Update Your Weed Management Plan?

As we are approaching a new year, Rural Municipalities' **weed management plans** are due for their yearly update. The Plant Health Technical Advisors are happy to help you update these documents every year. We can provide insight into weeds to watch for, weeds encroaching into the area, and weed control options. A detailed weed management plan will aid in the prevention and effective management of invasive weeds by allowing RMs to track and evaluate invasive weed issues, as well as outline the goals and priorities of the RM.

If your RM does not have a weed management plan but would like to develop one as you intend to utilize the Invasive Plant Control Program in 2025, feel free to reach out to your division's PHTA, and we can help you to put together the weed management plan for the RM.

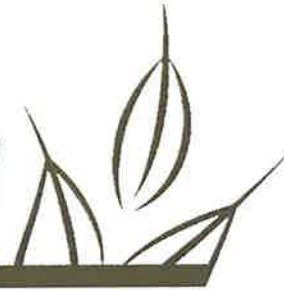

Effective January 1, 2025

The Canadian Free Trade Agreement (CFTA) requires any municipality interested in participating in a buying group to publish a declaration of its intent to participate in a buying group.

Participating in SARM's buying group includes purchases from SARM's Member Purchasing, Canoe Procurement Group of Canada, and Sourcewell.

**Effective January 1, 2025**, SARM's legal counsel has advised that the provisions of the CFTA requiring a procuring entity to publish a notice of participation with the buying group applies to each of SARM's members individually. The legal advice that we

received is that the RM is the procuring entity and it is the RM's responsibility to make this annual posting.

This posting is only required to remain active for two weeks. You will need to repeat this posting annually if purchases are planned for the year.

## Civic Address Registry (CAR) Signage Incentive Project

The Saskatchewan Public Safety Agency (SPSA) is pleased to announce the CAR Signage

Incentive Project. The project is a limited time offer to provide assistance with the cost of road name and civic address signage for Saskatchewan.

The Civic Address Registry (CAR) program works with communities to improve identification of property locations for 9-1-1 operators, dispatch services, and emergency responders. Communities that join CAR can participate in free training and access resources that locate properties more quickly and accurately.

The CAR Signage Incentive Project is being launched to encourage communities to participate in the CAR program and to increase the use of physical signage to assist in emergency response. There is no cost to participate in the CAR program or to apply for the incentive.

Further details of the project can be found below:

- This project is open to new and existing CAR community participants.
- The SPSA will subsidize the purchase of a community's civic address signs.
- To qualify for the signage incentive, participating communities must first complete the CAR Level 2 training by March 31, 2025. Training is free through CAR.
  - CAR Level 2 training qualifies participants for road signage.
  - CAR Level 3 training qualifies participants for civic address and road signage.
- **During this limited time offer, you can submit only one application per signage type.**
- The signage incentive is limited and distributed on a first-come, first-served basis.

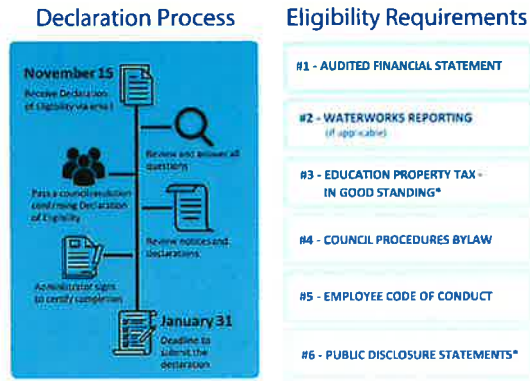

# Municipal Revenue Sharing Declaration of Eligibility

## Municipal Revenue Sharing Declaration of Eligibility

Municipalities are required to annually report their compliance with eligibility requirements to receive their Municipal Revenue Sharing (MRS) grant by completing an online Declaration of Eligibility (declaration). **The unique link and password for the online declaration have been emailed to each municipality on November 15, 2024.**

If you do not see the email in your inbox, please check your spam/junk folder and then contact [grcompliance@gov.sk.ca](mailto:grcompliance@gov.sk.ca) requesting the email be re-sent.

To avoid your municipality's MRS grant for the 2025-26 year from being withheld, ensure your municipality submits its declaration, which includes a resolution from council, and that your municipality meets all eligibility requirements.

The deadline for submission of the declaration is **January 31, 2025**. Please ensure the declaration is submitted by the deadline, even if the municipality does not meet all eligibility requirements.

## Municipal Tax Policy for Agricultural Crown Lands

With municipal taxes coming due December 31, now is a good time to become familiar with the Ministry of Agriculture's Municipal Tax Policy for agricultural Crown lands. This policy outlines how the ministry and the Rural Municipality (RM) can work together to ensure that any outstanding taxes levied on leased agricultural Crown land are paid in a timely fashion.

RMs can request payment for taxes owing on leased agricultural Crown land if there are any unpaid amounts five business days after December 31st of the year in which the taxes were levied. The first step is for

Furthermore, if there is vacant agricultural Crown land **with agricultural potential** in your RM, the ministry will pay a grant in lieu for 2024 municipal taxes. RMs can request a grant in lieu by contacting their district land management specialist. Please be aware the ministry will not pay interest or penalty fees.

The Municipal Tax Policy outlines the categories of land the ministry will pay a grant in lieu for municipal taxes:

- Vacant, titled and has continuing agricultural potential; and
- Vacant, untitled and has continuing agricultural potential.

The ministry does not pay a grant in lieu for municipal taxes for the following categories of land:

the RM to complete and submit the Agreement Cancellation Request Form to Corporate Services. Corporate Services will not be sending out this form, it has been linked below for your convenience. This form needs to be submitted no later than **February 5, 2025**. Due to the strict payment terms, late applications cannot be processed. If you have questions, please contact Corporate Services at [billinginquiry@gov.sk.ca](mailto:billinginquiry@gov.sk.ca) or 306.787.7191.

Once this form is received by the ministry, a Notice of Cancellation will be sent to the lessee if the amount owing is \$200 or more. If taxes are not paid by the lessee within 21 business days after the issuance of the Notice of Cancellation, the lease will be cancelled. The ministry will only pay up to one year of tax arrears (the 2024 tax year) to the RM directly and the ministry will take the necessary actions to recover the debt from the former lessee. If the RM receives payment for taxes, after the ministry provides a grant in lieu, from the former lessee on a cancelled lease, the RM will refund all taxes paid by the ministry.

- Leased (including former federal and provincial community pastures);
- Vacant, titled and has no continuing agricultural potential;
- Vacant, untitled and has no continuing agricultural potential;
- Permitted (the ministry collects a cheque from the permittee, written to the RM for taxes, when the permit is issued);
- Abandoned rail line lands transferred to the Crown but not incorporated into a Crown land lease; and
- Small acreages (10 acres or less) utilized for special purposes such as reservoirs, lagoons, transmission towers and from which no revenue is derived by the ministry.

## Community Rink Affordability Grant Application Period

Applications for the 2024-25 Community Rink Affordability Grant will open on January 6, 2025.

Communities, First Nations, schools and non-profits are eligible and encouraged to register for the annual grant of \$2,500 per indoor ice surface. The grant helps offset the costs of operating indoor skating and curling rinks in Saskatchewan.

The Saskatchewan government will double the program funding to \$3.2 million starting in 2025-26, increasing the grant to \$5,000 per rink.

The application period will run from **January 6, 2025, until February 28, 2025**, and the grant is set to be paid out by March 2025.

## RURAL TRANSIT SOLUTIONS FUND



### Housing, Infrastructure and Communities Canada's Rural Transit Solutions Fund: Capital Projects Stream

#### Call for Applications

The Minister of Housing, Infrastructure and Communities Canada, Sean Fraser, announced the launch of the Rural Transit Solutions Fund's Capital Projects stream intake under the **Canada Public Transit Fund**.

The Rural Transit Solutions Fund supports the development and expansion of locally driven transit solutions, by helping residents of rural, remote, Indigenous and Northern communities conduct their day-to-day activities, like access services, go to work, school, medical appointments, and visit loved ones.

Housing, Infrastructure and Communities Canada recognizes the diversity of Canada's rural and remote communities and their unique transit needs. The Fund supports a range of public transit models including fixed-routes, on demand transit and micromobility services, such as e-bikes.

Under the Capital Projects stream, eligible organizations with at least two years of transit experience, including local governments working in partnership with experienced transit organizations, or a completed public transit feasibility study (dated after January 1, 2020) can apply for a federal contribution of up to **\$10 million**. Organizations with less than two years of experience and no recent feasibility study may still qualify for up to **\$250,000** in federal funding. This funding helps cover the cost of capital assets, which includes purchasing vehicles and supporting infrastructure (e.g., bus stops and charging stations) for a transit system.

Applications for the Capital Projects stream will be accepted through the Housing, Infrastructure and Communities Canada's **Applicant Portal**. Applications will be accepted from all applicants until **March 4, 2025 (3:00 p.m. EST)**, while applications from Indigenous recipients will be accepted until **April 8, 2025 (3:00 p.m. EST)**.

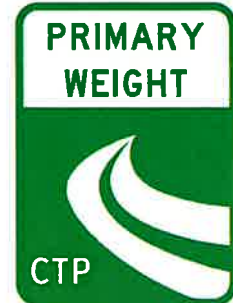

This form requires completion annually to confirm that the Road Authority has maintained the Corridor(s) to a safe and suitable level as described in their CTP Incremental Maintenance Funding Agreement.



For all following CTP programs beginning in the 2025-26 program year, the Statutory Declaration shall only be accepted from January 1st to March 30th of each year.

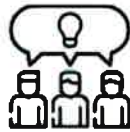

## Health Human Resources Action Plan December Update

A new incentive of up to \$200,000 over five years will be offered to support recruitment of graduates in Emergency Medicine. The incentive includes both specialist Emergency Medicine physicians and Family Medicine physicians who pursue additional training in Emergency Medicine.
